On 31 August 2017, the Company granted performance awards to eligible Incentive Participants pursuant to the Long Term Incentive Equity Plan adopted by the Company in 2012 (2017 Performance Awards). Upon vesting, award shares may be issued and allotted to eligible Incentive Participants to satisfy the performance awards, at a ratio of one award share for each performance award.

On 5 December 2017, the Company announced that the Board resolved to satisfy the performance awards in respect of the 2017 Performance Awards under the Long Term Incentive Equity Plan, to the extent they vest in accordance with their terms, by way of issue and allotment of up to 54,391,336 new Award Shares of the Company to Incentive Participants (including the Connected Incentive Participants) pursuant to the general mandate granted to the Board at the annual general meeting of the Company held on 24 May 2017. At the extraordinary general meeting of the Company held on 8 March 2018, the Independent Shareholders approved, to the extent they vest in accordance with the terms, the issue and allotment of up to 18,959,098 new Connected Award Shares of the Company to the Connected Incentive Participants in respect of the 2017 Performance Awards pursuant to the Long Term Incentive Equity Plan.

There are a total of 222,222 performance awards lapsed in the month of April 2018.
