- Headquartered in Australia, listed on The Stock Exchange of Hong Kong.
- Five major operating mines.
- Major producer of zinc and copper.



MMG in Africa Today



- Kinsevere copper mine in Katanga province, Democratic Republic of Congo.
- Exploration office in Lusaka, Zambia.
- Nachingwea nickel exploration Joint Venture in Tanzania.
- Support office in Johannesburg, South Africa.
- More than 1,900 MMG employees and contractors in DRC, 97% DRC nationals.






Kinsevere and copper – important to MMG



- Kinsevere located near Lubumbashi in Katanga.
- MMG owned and operated since February 2012.
- Capacity to produce 60,000 tonnes of 99.99% copper cathode.
- Approximately one third of total MMG copper production.
- Ongoing work program to improve electrical reliability and stability.
- Major employer in local community.



Contribution to MMG's Revenue



Kinsevere mine



- Comprises the Kinsevere Hill, Tshifufia and Tshifufiamashi deposits located
 27 km from Lubumbashi.
- Conventional open pit mining by MCK Trucks, a local registered contractor.
- Ore throughput 1.6 million tonnes per annum.
- Crushing, grinding, agitated leach, SX-EW to produce copper metal.
- LME Grade A equivalent cathode production.
- 21 diesel generators on site to address power supply disruptions.




Social licence to operate



- Substantial improvement in safety performance.
- Local initiatives include safety observation training.
- Malaria management plan.
- Women's health education sessions.
- School building and teacher support program.
- Water quality monitoring, bore & pump development – locally trained technicians.
- Continuing MMG's proven track record as a sustainable operator.

Strong relationships – sharing benefits



- MMG one of 21 members of the International Council of Mining and Metals (ICMM).
- Guided by 10 principles of Sustainable development including:
 - Governance
 - Human rights
 - Biodiversity
 - Economic and social development.
- Established effective relationships with national and local governments.
- Ongoing community consultation.
- Fostering local Chinese partners enabled by our major shareholder.





Vibrant community development program



- Committed to maximising local employment.
- Technical training program aimed at developing new skills in the community.
- Substantial progress made in sealing main mine road improving safety around site.
- Construction of Kifita village school.
- Equipped Kinsevere community clinic and supported Ministry of Health employees.
- 1,000 farmers supported, local produce purchased by MMG.





Promoting local training and education



- Long-term employment localisation program to increase the local workforce.
- Local employee management capability development program to run until 2015 to reduce the site expatriate employees ratio.



Challenges in the DRC



- Reliable and stable grid electricity supply.
- Road transportation and cross border administration for key supplies.
- Lack of railway improvements.
- Quality employee retention.
- Tax and royalty reform.
- Inconsistency between various DRC legislations.
- Telecommunication and IT support within the Government Administration.



Electricity – a major challenge



- Kinsevere power requirements continue to be drawn from the electricity grid with additional power sourced from diesel generation as required.
- 54% of power requirements were met from diesel generation in the first half 2013.
- MMG continues to negotiate supply with regional providers and pursue sustainable, long-term solutions.



DRC Mining Code Review




- We support a review of the DRC Mining Code.
- It is important to ensure long-term, sustainable development in the region.
- Any reform should:
 - Encourage mining and infrastructure investment in the region
 - Benefit local communities
 - Be internationally competitive
 - Not negatively financially impact the owners of existing projects
 - Ultimately create a sustainable, stable and prospective mining sector.
- Good engagement to date important for industry to collaboratively approach change.

MMG's future in the DRC



- Near mine exploration to extend Kinsevere mine life.
- Relationships of trust with communities and Government to create win-win outcomes.
- Develop skills and capacity in local communities through education and training.
- Contribute to socioeconomic development in the Kinsevere region
- Collaborate with other miners to create a business environment supportive of investment and economic growth
- Engage with Gécamines as partner in mining projects.
- Drive new power projects to solve current shortage.
