On 29 June 2018, the Company granted a total of 9,517,609 performance awards to eligible Incentive Participants pursuant to the Long Term Incentive Equity Plan adopted by the Company in 2012 (2018 Performance Awards). The time of vesting will be on or around June 2021. Upon vesting, award shares may be issued and allotted to eligible Incentive Participants to satisfy the Performance awards, at a ratio of one award share for each performance award.

There are a total of 5,831,793 performance awards lapsed in June 2021.

2. On 3 May 2019, the Company granted a total of 22,194,175 performance awards to eligible Incentive Participants pursuant to the Long Term Incentive Equity Plan adopted by the Company in 2012 (2019 Performance Awards). The time of vesting will be on or around June 2022. Upon vesting, award shares may be issued and allotted to eligible Incentive Participants to satisfy the Performance awards, at a ratio of one award share for each performance award.

3. On 29 April 2020, the Company granted a total of 72,739,897 performance awards to eligible Incentive Participants pursuant to the Long Term Incentive Equity Plan adopted by the Company in 2012 (2020 Performance Awards). The time of vesting will be on or around June 2023. Upon vesting, award shares may be issued and allotted to eligible Incentive Participants to satisfy the Performance awards, at a ratio of one award share for each performance award.

There are a total of 796,118 performance awards lapsed in June 2021.

4. On 21 June 2021, the Company granted a total of 21,306,781 performance awards to eligible Incentive Participants pursuant to the Long Term Incentive Equity Plan adopted by the Company in 2012 (2021 Performance Awards). The time of vesting will be on or around June 2024. Upon vesting, award shares may be issued and allotted to eligible Incentive Participants to satisfy the Performance awards, at a ratio of one award share for each performance award.
