On 21 April 2022, the Company granted a total of 29,882,658 performance awards to eligible Incentive Participants pursuant to the Long Term Incentive Equity Plan adopted by the Company in 2012 (2022 Performance Awards). The time of vesting will be on or around June 2025. Upon vesting, award shares may be issued and allotted to eligible Incentive Participants to satisfy the Performance awards, at a ratio of one award share for each performance award.
